Notes to accompany quotation of Conveyancing fees on a Purchase.

- Acting for lender fee. If you are having a mortgage to buy your home, your mortgage lender will also instruct your conveyancer to act on their behalf. This is the law firms charge for acting for the lender as well as you.
- Search fees. The searches carried out will include a Local Search, Drainage & Water Search and an Environmental Search. Your conveyancer will advise if any other searches are advisable i.e. Flood Search.
- 3. Land Registry fees. This fee is payable to the HM Land Registry to register the property in your name. The fees quoted are based on this not being a new property (first registration) and that the law firm submits the forms electronically. If this is not the case a higher fee may apply and your law firm will notify you of the charge at the outset of the transaction.
- Stemp Duty Land Tax, SDLT is a government tax and is payable for all purchases at varying rates depending on the transaction.

Stamp Duty has been calculated for this transaction based on the following items selected whilst quoting, your conveyancer will confirm the charge payable.
